How often does WSBF notify me about their practices?	We must notify you about ou sharing practices when you open an account and each year while you are a customer
How does WSBF protect my personal information?	To protect your personal information from unauthorized access and use we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does WSBF collect my personal information?	We collect your personal information, for example, when you • Open an account or deposit money • Pay your bills or apply for a loan • Use your debit card We also collect your personal information from others, such as credit bureaus, affiliates or other companies.
Why can't I limit all sharing	Federal law gives you the right to limit sharing only for • Affiliates' everyday business purposes - information about your creditworthiness • Affiliates to market to you • Non-affiliates to market to you State laws and individual companies may give you additional rights to limit sharing.

Everyday business purpose	The actions necessary for financial companies to run their business and manage customer accounts, such as • Processing transactions, mailing, and auditing services • Providing information to credit bureaus • Responding to court
	orders and legal investigations
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.
